Dear Senator MacKinnon:

My name is Rainier Herczeg. I am a potential constituent, youth activist, and University of Alaska Anchorage undergraduate from District 14. I am writing to request your support for House Bill No. 111. HB 111 will move Alaska forward economically and environmentally. The Bill is currently under review by the Senate Finance Committee and has the potential to reduce Alaska's economic dependency on oil and gas, which could result in increased focus on renewable energy investment. HB 111 increases oil companies' minimum tax rate by 1% (4% to 5%), decreases the percentage of loss able to be converted into tax credit (35% to 15%), and lowers the caps for annual subsidies by half (70 million to 35 million) (Herz, 2017).

Alaska faces unique challenges as the only Arctic state in the nation and as a base for oil and gas production. As a young person in Alaska, planning for a sustainable future is my highest priority. As my representative, you have the opportunity to make great changes for the State of Alaska, and you have a responsibility to do what is right for future generations.

Please consider these facts regarding the passage of HB 111:

- The low price of oil is causing a large deficit for the State of Alaska. Even with increased production, the amount of revenue Alaska loses to tax credits (775 million) does not make up for the combined revenue from royalties (700 million) and production taxes (68 million) (DeMarban, 2016).
- By investing less money in fossil fuels, Alaska can increase funding for renewable energy projects. This will lower dependency on oil and gas, increase energy sustainability, and can

financially benefit Alaskans. Since 2006, the Alaska Village Electric Cooperative (AVEC) has used wind turbines for 4% of the energy production and saved \$8,000,000 in fuel costs (AVEC, 2015). In Kotzebue, the Kotzebue Electric Association uses wind farms to generate up to 20% of its electricity, saving from 1-1.25 million dollars a year, reducing the cost of electricity for residents by 10 cents per kilowatt hour (Edgerly, 2015).

- Alaska investing in renewable energy means that future generations will be able to enjoy its natural wonders. The Arctic is in grave danger from the threats posed by manmade climate change. The emission of nitrogen oxide from fossil fuel burning vehicles is one of the leading causes of our warming climate. The increased greenhouse gasses in the atmosphere trap the heat from the sun and warm the global climate (NASA, 2017). This affects Alaska in a dramatic way, Alaska's average temperature has increased by 3°F over the last 60 years. That twice as much compared to the rest of the nation. This warming negatively impacts infrastructure by warming the permafrost, increases the chance of forest fires, disrupts ecosystems for important Alaskan wildlife, and increases the rate of coastal erosion (EPA, 2017).

The points I listed above clearly show that it is time for Alaska to move its focus from oil and gas to sustainable, environmentally friendly, and economically advantageous energy investments. HB 111 will set us on that path. Once again I ask for your support on HB 111.
